 - To protect the Miracle League player at all times.
 - When a hard hitter is up to bat, Buddies are to step in front of their Miracle League Player for protection.
 - Always allow the Miracle League Player as much freedom as possible to play his/her own game.
 - Assist Miracle League Player according to their needs.
 - Be of good spirit with enthusiasm, love, good attitude and concern in motivating the players and their families.
 - Become their friend; get to know the players and their families.
 - Arrive at field 30 minutes prior to game time.
 - Be properly dressed and clean in a Miracle League Buddies shirt.
 - Commit to all games and tell coordinator in advance of any games that will be missed.
 - Demonstrate high morals and integrity on and off the field.

I understand that there will be media and promotional coverage of Miracle League Games and activities and I give my consent to publish my name and picture for such purposes.
